OBJECTIVES

The objects for which the Association is established are: -

- (1) To undertake fish stocking of dam impoundments and waterways within the North and South Pine Rivers' catchment for recreational angling and for conservation purposes;
- (2) To encourage and assist the research pertaining to the management of fisheries in natural and altered waterways;
- (3) To seek to protect and safeguard the aquatic environment of the North and South Pine Rivers' system;
- (4) To promote ethical and legal fishing practices;
- (5) To promote and encourage conservation amongst all anglers;
- (6) To liaise with the owners of any water storage impoundments within the catchment of the North and South Pine Rivers' system to promote the Association's activities and objectives;
- (7) To liaise and cooperate with the relevant Queensland Government Department/s in relation to fisheries management;
- (8) To liaise with other organisations and interested members of the public with similar aims and objectives to encourage them to participate with the Association in meeting its objectives;
- (9) To promote the sport and recreational aspects of fishing to members of the public, particularly disadvantaged persons;
- (10) To undertake the aquaculture of endemic or other permitted native fish species for the purpose of enhancing the environmental amenity within the Moreton Bay Regional Council area.

Guidelines for participation:

1. Abide by the Constitution of the Pine Rivers Fish Management Association Inc;
2. Abide by resolutions passed by the Management Committee;
3. Abide by motions passed at Annual General Meeting, General and Monthly meetings;
4. Not to correspond in any medium about matters discussed and/or dealt with in the conduct of PRFMA business without the approval of the Management Committee.
5. Not to engage in any conduct which might cause (or perceive to cause) embarrassment or harm to the name or reputation of the Association, or in any way prejudice the operations of the PRFMA
